PIERCE COUNTY HUMAN SERVICES
LANDLORD LIAISON PROGRAM**

Pierce County's Human Services and the Tacoma Housing Authority are soliciting applications for the Landlord Liaison Program. The Notice of Funding Availability (NOFA) for approximately **\$411,000** in funding from the Homeless Document Recording Fee and Tacoma Housing Authority funding. Pierce County and Tacoma Housing Authority are soliciting applications from eligible, qualified, and interested organizations to engage, recruit and establish partnerships with landlords and property management companies countywide to improve access to rental housing for homeless and low-income households in the County. The successful applicant(s) primary role will be to establish formal business agreements with landlords willing to work with and/or reduce screening criteria for households with rental barriers. The funding will be offered in the form of a grant.

The County will hold one application workshop on Tuesday, April 13, 2021 at 1:00 pm. The NOFA includes a link to join the ZOOM webinar.

The NOFA will be posted and available online on Tuesday, March 30, 2021.
